TREYMOORE POOL RULES & REGULATIONS 2025

Pool Hours are 9:00AM Until 9:00PM

- There is no lifeguard, you swim at your own risk.
- Children under 15 may NOT be at the pool without an adult or person over 18.
- The amenities are for the use of Treymoore Homeowners and their guests.
- Cameras and security systems are present on the property.
- Guests are limited to 5 people per household at one time. Any more than that requires written approval from the Board. Please submit your request by email to <u>hoatreymoore@gmail.com</u>.
- Umbrellas must be down before leaving the pool. Treat pool furniture with care.
- No glass containers or bottles are allowed inside the pool area.
- All babies/toddlers MUST wear swim diapers/rubber pants.
- Persons with communicable diseases should not enter the pool.
- No running, pushing, jumping, diving, dunking or holding others under water.
- No animals or pets are allowed in the pool area.
- No smoking or illegal drugs are permitted inside pool gate or surrounding area.
- All trash must be placed inside the garbage containers.
- No profane or abusive language will be tolerated.
- No sharp objects or hazardous materials will be allowed in the pool area.
- No pool furniture is to be used in the pool or baby pool.
- No over-sized pool floats are permitted.
- Pool Gates must always remain closed, no propping gates open.
- Bathers must wear swim attire. No "cut-offs" or shorts allowed for swimming.
- No underage solo swimming.
- No spitting, spouting of water or nose blowing is permitted in the pool.
- Absolutely NO wheeled toys in the pool area.
- No fireworks, sparklers, poppers or other related items are to be used in the pool area or pool parking lot.
- Music should be played at volumes that do not disturb others.
- The pool phone is ONLY to be used for emergencies. (911 calls).
- Food and beverages are allowed at the pool side only, NOT in the water.
- Pool/Birthday parties are permitted only with prior approval from the board members: (refer to guest limits). Pool parties will not be allowed during weekend peak times. - All amenity privileges are revoked for anyone owing fees to the Association or found violating the above policies. Revoking privileges is up to the discretion of the Board.

TREYMOORE TENNIS RULES & REGULATIONS

2025 Pool Hours are 9:00AM Until 9:00PM

- Children under the age of 15 must be accompanied by an adult.
- Tennis courts are to be used exclusively for tennis and pickleball. Activities such as skateboarding, softball/baseball hitting practice, and bike riding are strictly prohibited.
- All players may reserve courts through the following website: www.reservemycourt.com you must first register as a player. Once you register, an automated email will be sent to the HOA. Once the HOA receives your initial registration, you will be sent a code to complete your registration. You will then be able to make reservations.
- Reservations can be made for up to two hours. One court may be booked at a time and one court per day.
- If a person holding a reservation is 10 minutes late, that court may be considered open for play.
- **Courts may only be reserved by residents of Treymoore.** Those residents must be in good standing: current on all dues and fines.
- If a court is not reserved, they may be used on a first come, first served basis.
- All regularly scheduled group tennis lessons must be approved by the Board. A usage fee of \$20 per session will apply.
- Any summer camps must be approved by the Board; a usage fee will apply.
- ALTA/USTA teams must be approved by the Board each season.
 - Out of neighborhood player fees of \$25 are required and must be collected prior to each season and submitted to the Board. A \$50 late fee will be applied to all teams not in compliance.
 - Fees should be submitted directly to a Board member. The Board reserves the right to revoke permission to any teams at any time based solely on their discretion.
 - Current residents are permitted to use Treymoore courts for ALTA/USTA teams only if HOA dues and fees are paid in full.
 - After practices and matches, ALTA/USTA captains are responsible for the following: emptying trash cans on the courts; locking the gates; cleaning the observation area; cleaning food areas; checking the bathrooms for cleanliness.
- No profanity or screaming is permitted.
- No smoking on the courts.
- No glass bottles are permitted on the courts.
- No loud music is permitted on the courts.
- No fireworks, sparklers, poppers or any such items are to be used on the courts.
- Lights must be turned off after playing.
- Playing privileges will be revoked if rules are not followed.
